





FJA: Board of Governors

FJA is a body corporate having perpetual succession and a common seal with power to acquire, hold and dispose of property both moveable and immovable and shall by the said name sue and be sued. The management of its affairs vests in the Board of Governors which currently consists of:-

- 1. Hon'ble Mr. Justice Mian Saqib Nisar, Chief Justice of Pakistan Chairman
- 2. Mr. Zahid Hamid, Federal Minister for Law, Justice & Human Rights Vice Chairman
- 3. Mr. Ashtar Ausaf Ali, Attorney General for Pakistan Member
- 4. Hon'ble Mr. Justice Muhammad Anwar Khan Kasi, Chief Justice, Islamabad High Court Member
- 5. Hon'ble Mr. Justice Muhammad Noor Meskanzai, Chief Justice, Balochistan High Court Member
- 6. Hon'ble Mr. Justice Yahya Afridi, Chief Justice, Peshawar High Court Member
- 7. Hon'ble Mr. Justice Ahmed Ali M. Shaikh, Chief Justice, High Court of Sindh Member
- 8. Mr. Justice Syed Mansoor Ali Shah, Chief Justice, Lahore High Court Member

Role and Powers of the BoG under the Federal Judicial Academy Act, 1997

- 1. The Board of Governors, shall *inter alia*:
 - (a) Exercise general supervision over the affairs of the Academy;
 - (aa) Award degrees, diplomas and certificates;
 - (ab) Approve academic and research programmes;
 - (b) Lay down the policy and programme for training and approve courses of training
 - (c) Evaluate and examine the activities of the Academy;
 - (d) Approve and consider the annual budget and revised budget estimates;
 - (e) Receive grants-in-aid from the Federal Government, Provincial Governments and aid giving agencies;
 - (f) Cause proper books of account to be maintained for all sums of money received and expended by the Academy and arrange for audit by the Auditor-General of Pakistan;
 - (g) Prescribe the terms and conditions of service of the Director General and member of the staff;
 - (h) Create, abolish, suspend and upgrade posts;
 - (i) Prescribe duties of the members of the staff;
 - (j) Appoint, suspend, punish, dismiss or remove from service any member of the staff;
 - (k) Purchase, hire, construct or alter building for the Academy;
 - (l) Hold, control and administer the moveable and immovable property, assets and funds of the Academy;
 - (m) Regulate, determine and administer all matters concerning the
 - (n) Affiliate with Provincial judicial academies and other training and educational institutions; and
 - (o) Decide any matter ancillary and incidental to the aims and objects of the Academy.
- 2. Under Section 7 of the Act, the Board may delegate all or any powers and functions to the Chairman, Vice Chairman, any member of the Board, the Director General or any member of the staff.
- 3. Under Section 9(5) of the Act, the Board is also authorized to appoint such committees and

working groups from amongst its members, or otherwise, as and when it may consider necessary.

4. Under Section 10 of the Act, the management of the Academy is carried out, under the general directions of the Board, by the Director General as its academic and administrative head. He is responsible for the maintenance of good order and discipline, and is also the Principal Accounting Officer of the Academy.

Management and Functions

Director General

- 1. The Director-General shall be appointed by the Chairman on such terms and conditions as may be approved by the Board.
- 2. The management of the Academy is carried on by the Director-General under the general directions of the Board.
- 3. The Director-General is the academic and administrative head of the Academy and also responsible for the maintenance of good order and discipline.
- 4. The Director-General shall be the Principal Accounting Officer of the Academy.

Appointment of Officers and Members of Staff of Academy

- 1. The members of the Staff of the Academy are appointed by direct recruitment or transfer, or deputation or on contract basis or otherwise in such manner and on such terms and conditions as may be approved by the Board,
- 2. All appointments of the members of the staff to posts in Basic Pay Scale 1 to 16 are made by the Director-General with the approval of the Chairman.
- 3. Appointment of the members of the staff to posts in Basic Pay Scale 17 and above are made by the Chairman.

Profiles of Hon'ble Chairman/Members

Honourable Mr. Justice Mian Saqib Nisar Chief Justice of Pakistan

onourable Mr. Justice Mian Saqib Nisar was born on 18.01.1954 at Lahore. He did his Matriculation from Cathedral High School, Lahore and Graduation from Government College, Lahore. Thereafter he completed his Bachelor of Law from the University of Punjab in the year 1979-80 following



which he joined the legal profession as an Advocate on 02.05.1980. He was enrolled as an Advocate of the High Courts in 1982 and an Advocate of the Honourable Supreme Court of Pakistan in 1994. Subsequently, he was elevated as a Judge of the Lahore High Court on 22.05.1998, and the Supreme Court of Pakistan on 18.02.2010. His lordship took oath as the Chief Justice of Pakistan on 31.12.2016.

His lordship practiced civil, commercial, tax and constitutional law and appeared in numerous important constitutional cases before the High Courts and the Supreme Court. He was elected as Secretary General of the Lahore High Court Bar Association in the year 1991. On 29.03.1997, he was appointed as Federal Law Secretary. It was the first time in the history of the country that a member of the Bar was appointed to this position.

Mr. Justice Mian Saqib Nisar was a member of the delegation representing Pakistan in the "International Youth Conference" held in Libya, Tripoli in 1973. He represented Pakistan in the International Conference on "Pakistan and India at Fifty" held in Wilton Park, United Kingdom. His lordship led the Pakistani delegation at a minister level conference on "Asia Region Transitional Crimes" held in Manila, Philippines and the Pakistani delegation on Human Rights to Switzerland. He participated in a conference held in Oslo, Norway in February, 2009 under the auspices of the Pakistani community in collaboration with the Norwegian Ministry of Foreign Affairs on the subject of "Islam and Democracy" and read a paper on the "Role of the Courts in Islamic Democratic Society". His lordship also remained a part-time lecturer at Punjab Law College and Pakistan College of Law, where he taught civil procedure and constitutional law.



Mr. Zahid Hamid
Federal Minister for Law & Justice/ Vice Chairman, BoG

r. Zahid Hamid is Federal Minister for Law and Justice in the Cabinet of Prime Minister Mian Muhammad Nawaz Sharif. He has been elected to the National Assembly from NA-114, District Sialkot thrice consecutively-in 2002, 2008 and 2013.

Born on October 24, 1947 in Lahore, he obtained his B.A. (Honours) and M.A. degrees from the University of Cambridge, UK and LLB degree from the University of Punjab, Lahore.

He has attended courses/ seminars at Harvard University Graduate School of Business Administration and the International Development Law Institute, Rome. In 1970 he joined the Civil Service of Pakistan (CSP) and held various field and staff appointments in the Government of the Punjab before resigning in 1978.

As a successful entrepreneur, he set up and managed two industrial units in the food sector (1978-1988). He has previously served as Minister of State for Defense, Federal Minister for Privatization and Investment, and Federal Minister for Law, Justice and Human Rights (2004-2007).

Mr Zahid Hamid is a lawyer by profession and an Advocate of the Supreme Court of Pakistan. He has worked extensively in the field of environmental law in particular and has drafted a number of environmental laws and written a number of papers on various issues relating to the environment. He is the principal draftsperson of the Pakistan Environment Protection Act, 1997, and the Rules / Regulations prescribed thereunder. He has been a member of the Pakistan Environmental Protection Council and the IUCN Commission on Environmental Law, Bonn and has undertaken studies for the World Bank and Asian Development Bank. He has also been a member of the Banking Laws Review Commission. When the PML (N) was in the Opposition (2008-2013) Mr Zahid Hamid, was Convenor of the PML (N) Parliamentary Party's Law Committee and had played a lead role in advising, drafting and piloting amendments in the Constitution and other bills.

Mr Zahid Hamid was also elected as member of the National Assembly's Standing Committees on Public Accounts; Law, Justice and Human Rights; and Local Government and Rural Development.

Mr. Ashtar Ausaf Ali Attorney General for Pakistan

orn in Lahore on 19 June 1956, Mr. Ashtar Ausaf Ali is a lawyer and the 32nd Attorney General of Pakistan. He previously served as Special Assistant to the Prime Minister on Law with the status of Minister of State from 25 February 2015 to 28 March 2016. He also served as Advocate General of Punjab twice, from 1998 to 1999 and 2012 to 2013, and as Advocate General of the province from 2011 to 2012.



Education and Early Life

Mr. Ashtar Ausaf Ali is the eldest son of a renowned lawyer Mr. Iftikhar Ali Sheikh. He completed his Bachelor of Arts from F.C College Lahore in 1975, and his LL.B from Punjab University in 1980, where he also taught as adjunct lecturer for international law from 1984 to 1988. He became member of the Lahore Bar Association in 1980, and was awarded an MCL from George Washington University, where he was a member of the Phi Delta Phi legal fraternity.

Mr. Ashtar Ausaf Ali came to prominence in the 1990s as a litigator and constitutional lawyer. After President Ghulam Ishaq Khan dismissed the government of Prime Minister Nawaz Sharif in 1993, he successfully represented Mian Muhammad Nawaz Sharif before the Supreme Court of Pakistan against the dissolution of the Parliament. As a result, the Supreme Court overturned President Ghulam Ishaq Khan's dismissal of the Parliament, and Mian Muhammad Nawaz Sharif was re-elected in 1997. Mr. Ausaf was then appointed Advisor to the Prime Minister on Human Rights. He was appointed Advocate General of Punjab in May 1998, but he resigned from this post when General (Retd.) Pervez Musharraf overthrew the government of Mian Muhammad Nawaz Sharif in a military coup.

Mr. Ashtar Ausaf Ali was appointed as Attorney General for Pakistan on 29 March 2016. In addition, he also heads the Treaty Implementation Cell (TIC) established by the Government of Pakistan that is mandated an oversight role for the implementation of international human rights treaties and conventions ratified by Pakistan.



Mr. Justice Muhammad Anwar Khan Kasi Hon'ble Chief Justice, Islamabad High Court

onourable Mr. Justice Muhammad Anwar Khan Kasi is a descendent of a famous Pashtun tribe "Kasi" settled in Quetta since ages. Born in an educated business family on 28th November 1956, he received his early education from Tameer-e-Nau Public School Quetta. After doing his F.Sc from Government Science College Quetta in 1975, he did his graduation from the University of Baluchistan in 1978. Thereafter, Justice Kasi

received his Master's degree in Economics in 1st Division and LL.B from Balochistan University in 1980-81. He was enrolled as an advocate in 1982. After practicing law as an advocate for four years, he joined the judicial service of Balochistan as a Civil Judge in May, 1986. Besides working as a Civil Judge on various stations, he worked as a Section Officer (Solicitor) Law Department, Government of Balochistan.

Justice Kasi was appointed as an Additional District and Sessions Judge in 1991 and was promoted as District and Sessions Judge in 1997. He worked as District and Sessions Judge in the remote tribal areas including Nasirabad, Dera Muraad Jamali, Sibi, Noshki, Kharan, Musakhail, Pishin, Zhob, Chaman and Quetta. He also served as Member Industrial Relations Commission Islamabad 1999, Judge Accountability Court No.1 Balochistan from 2000 to 2003, Judge Anti-Corruption Court 2009 and Member Balochistan Services Tribunal from 2009/2010. He was elevated as Judge of the Islamabad High Court on 4th January 2011. He gained vast experience in all disciplines of law including criminal, civil, revenue, customs and service.

In his career as a Judge, Justice Kasi received his professional training from Federal Judicial Academy Islamabad in 1999. He participated in various conferences and workshops which include "First Judicial Conference" held in Quetta 2002, Workshop on "Citizen Court Liaison" held in Federal Judicial Academy Islamabad 2003, Workshop on "Pakistan Environmental Protection Act 1997" in Quetta 2003, Workshop on "Judicial Ethics" 2004, and Workshop on "International Mechanism for protection of Human Rights of Refugees and bonded labor" 2004. He had also been a sports man in the field of hiking, hunting and riding. Besides his native language, he is fluent in almost all the local languages of Pakistan including Brahvi, Balochi, Sindhi, Persian and Punjabi. He took oath as Chief Justice Islamabad High Court on February 25, 2013.

Mr. Justice Muhammad Noor Meskanzai

Hon'ble Chief Justice, Balochistan High Court

r. Justice Muhammad Noor Meskanzai was born on 1st September 1956, at Kunri, District Kharan. He completed his primary education from the Government Middle School (now High School), Kunri, which was founded by his honourable father, Dr. Molvi Muhammad Qasim Aini Baloch. It was the first ever private School at Kharan District. Subsequently, it was nationalized by the Government in 1951-1952.



After completing his matriculation from Government High School Kharan, he went to Quetta for further education.

Justice Meskanzai did his F.A. from the Government Degree College, Quetta and proceeded to do his B.A and B.Ed. from the Balochistan University. He wrote a thesis on the topic "Democratic Concept of Educational Administration," which was highly appreciated. He did his LL.B. from the University Law College, Quetta in 1979-1980.


He started his legal practice in September 1981, at Quetta. While in private practice, Justice Muhammad Noor Meskanzai also took on the responsibility of being a Legal Advisor to Custom, Mekran Division, and Mekran Scout, at Turbat. He was also a member of the Panel of Legal Advisors to PTCL Mekran Division.

Justice Meskanzai was appointed as Assistant Advocate General Balochistan and worked in that position from June to December, 1998. He was elected as Vice Chairman of the Balochistan Bar Council from 24th of March 2005 to 24th of March, 2006. He was elected as Chairman Executive Committee for two terms. Before he was elevated as Additional Judge, High Court of Balochistan, Justice Meskanzai worked as Chairman of the Inter-Provincial Relations Committee, Balochistan Bar Council. He was also a member of the Common Wealth Legal Education Association.

Justice Meskanzai is a member of the Administration Committee. He has attended a workshop on International Law for Judges on, 'Meeting International Human Rights Standards in Criminal Proceeding', which was held in the Haugue, Netherlands in 2012, and the International Judicial Conference held in Islamabad on 13th to the 15th of April 2012. Muhammad Noor Meskanzai also attended the conference on Environmental Law 2011, in Quetta.

Mr. Justice Muhammad Noor Meskanzai was elevated as Additional Judge, in Balochistan High Court on the 7th of September 2009, and was later confirmed as Judge of the Balochistan High Court on the 11th of May, 2011.

Mr. Justice Muhammad Noor Meskanzai took oath as Chief Justice of the High Court of Balochistan on December 26, 2014.



Mr. Justice Yahya Afridi
Hon'ble Chief Justice, Peshawar High Court



Mr. Justice Ahmed Ali M. Shaikh Hon'ble Chief Justice, High Court of Sindh

r. Justice Ahmed Ali M. Shaikh was born on 3rd October, 1961. He got his early education from Government Pilot School, Larkana and graduated in

Science from Government Degree College, Larkana. He received his law degree from Shah Abdul Latif University, Khairpur.

On 1st November, 1990, Justice Ahmed Ali was enrolled as an Advocate of the subordinate courts. On 15th March, 1993, he was enrolled as an Advocate High Court where he maintained with ability his leading position at the Bar. In 1994 and 1995 he was elected as Vice President and General Secretary, respectively, of District Bar Association Larkana, and was later elected as the President of High Court Bar Association Larkana for the period April 05, 2008 to September 24, 2009.

Mr. Justice Ahmed Ali M. Shaikh was elevated as an Additional Judge, High Court of Sindh on 25th September, 2009 and took his oath as a confirmed Judge on 19th September, 2011. 
Mr. Karamat Hussain Niazi

2). Hon'ble Mr. Justice Umar Ata Bandial

r. Justice Umar Ata Bandial was born on 17.09.1958 at Lahore. He received his elementary and secondary education at different schools in Kohat, Rawalpindi, Peshawar and Lahore. He got his Senior Cambridge certificate in the year 1973 from St. Mary's Academy, Rawalpindi and Higher Senior Cambridge certificate from Aitchison College in the year 1975. He secured his B.A. (Economics) degree from Columbia University, USA in the year 1979 followed by a Law Tripos degree



from Cambridge University, UK in 1981. In 1982 he qualified as Barrister-at-Law from Lincoln's Inn, London. In the same year, he enrolled as an Advocate of the Lahore High Court and some years later, as an Advocate of the Supreme Court of Pakistan.

Justice Umar Ata Bandial established his law practice at Lahore dealing mostly with commercial, banking, tax and property law matters. After 1993 until his elevation, Justice Umar Ata Bandial also handled international commercial disputes. He appeared in arbitration matters before the Supreme Court of Pakistan and also before foreign arbitral tribunals in London and Paris. He remained professionally associated in the Hitachi-Rupali dispute (1998), the Hubco-GoP dispute (2000), the Ghazi Barotha Contractors-WAPDA dispute (2001) and the Bayinder NHA dispute (2004).

Justice Umar Ata Bandial was elevated as Judge of the Lahore High Court on 04.12.2004. He declined oath under PCO in November, 2007 but was restored as a judge of the Lahore High Court as a result of the lawyers and civil society movement for revival of the Judiciary and Constitutional rule in the country.

During his career as Judge of the Lahore High Court, Justice Umar Ata Bandial rendered judgments on a number of important public law and private law issues. These include the affirmation of the autonomy and independence of the office of Chief Election Commissioner; the sanctity of the office of the President as symbol of the unity of the Federation requiring its detachment from political involvement and activity; the necessity of ensuring transparency and competition in governmental licensing of Hajj Group Organizers in a Rs.9.25 billion annual business; holdingthe Lahore skyline to be public property for purposes of local authority regulation of sky signs; declaring the decisions of the Council of Common Interests in the matter of Kalabagh Dam to possess sanctity and enforceability unless modified according to the Constitution; the enforcement of transparency and merit criteria for appointment of Provincial Public Prosecutors.

Justice Umar Ata Bandial was appointed as Chief Justice of Lahore High Court, Lahore on 01.06.2012 and served in that office until his elevation as Judge of the Supreme Court of Pakistan on 17.06.2014.

Whilst practicing as an Advocate he taught Contract Law at the Punjab University Law College for four years until 1987 and remained a member of its Graduate Studies Committee whilst serving as Judge Lahore High Court.

Chapter-2

Federal Judicial Academy

he raison d'être behind the creation of the Federal Judicial Academy is to ensure that it imparts high-quality training to enable judicial officers, law officers, attorneys and court personnel to discharge their duties effectively in a way that carries the functioning of judicial system and promotes public confidence in the judiciary.



Before the creation of provincial academies, this premiere judicial training Academy hadbeen engaged in the following activities:

- i. Orientations/Induction Training for newly recruited or promoted judges;
- ii. Continuing Judicial Education on-the-job training programmes to equip judges and other subjects under its mandate to keep abreast with the changing developments in law, society and the environment at national and international level; and
- iii Organizing seminars, conferences, workshops on diverse issues relating to the justice sector.

After the establishment of provincial academies to resolve the issue of overlapping of functions and resources, the Academy now strives to provide pre-service as well as in-service training and education in many specialized subjects to judges of district judiciary, court personnel and other professionals. It also provides a forum to professionals from all over Pakistan to share their experiences and knowledge. The object of the Academy, however, is not only education and dissemination of knowledge and information about new laws but also to develop behaviors, to motivate and to inculcate values that are essential to professional excellence. During the trainings, the Academy makes every possible effort to enhance and enrich their knowledge; sharpen their skills such as communication, control of hearings, time management; and personal qualities such as commitment to fairness, promoting perceptions of fairness, tolerance, and sensitivity to difference of opinion, even punctuality and discipline.

The Academy, besides its mandate aims and objects, provides the participants of different courses an opportunity to ventilate their feelings, and to express practical problems and other on job difficulties. They are also allowed to offer and share solutions and resolve issues/problems, if any, and if possible at the appropriate level. The Academy thus leaves no stone unturned to improve the professional competence of judges and consequently, the quality of justice administered in the courts.

Principles of Policy

Principles of Policy are a set of rules to prescribe the limits and extent of the role and attitude of the faculty members. The principles clearly lay down and define the direction which can be taken by a training institute / Academy as a matter of policy.

Federal Judicial Academy imparts in-service training to the judges, magistrates, law officers and the court personnel, for the achievements of ultimate goal of improving the judicial system and quality of justice. The distinction lies, amongst others, in the fact that there is need for distinctive approach to the continued education of judges. This approach should build on the foundation of adult education and professional learning theory. More importantly, the faculty should be aware of the specific learning needs and practices of the judges and how the perseverance of judicial independence can be ensured. Another distinctive feature is the effect and impact of training provided to the judges, on the socio-economic development of the country, and its role in shaping the parameters of a civilized society.

The following principles of policy have, therefore, been set out to define and prescribe the parameters, to be observed by the faculty in particular and the staff in general, and the extent of their authority, in the performance of their functions, for the promotion and fulfilment of its charter:

The Academy shall:

- O bring home the message that judicial power is a sacred trust and that the judges are accountable to their conscience and ultimately to God Almighty;
- ensure and promote the observance of legal and judicial norms and Islamic values in the continued education of judges and other professionals related to the justice sector;
- ensure the observance of high ethical standards and preserve impartiality, independence and professionalism;
- help the judges, law officers, court personnel and other key stakeholders of the administration of justice to adhere to the highest standards of personal and official conduct;
- O establish an internal organizational structure, administration and program development system which supports effective legal and judicial education;

• establish and promote a comprehensive judicial education process to help judges meet the expectations of the society;

- endeavour to preserve the judicial system's fairness, integrity and impartiality by eliminating bias and prejudice;
- O improve the administration of justice and the quality of judicial decisions to strengthen the moral authority of the courts;
- O promote the concept of transparency and accountability and enhance public confidence in the administration of justice;
- endeavour to make trainee judges believe that they are not employees in the sense of "employment" and administration that they exercise the authority of the State as given to them by law and prescribed procedure;
- endeavour to cause conviction in the trainee judges that they have to perform unique functions and discharge special responsibilities;
- address itself to public perception of judicial weakness which can be removed through continuing judicial education;
- sensitize the trainee judges to decide cases in accordance with the law which they believe applies to the case before them, free from extraneous considerations of sanction or reward;
- O strive to groom impartial and independent judges-attributes, which are 'sine qua non' for the proper discharge of the judicial functions;
- strengthen ethical values and professionalism among officers to promote efficient, effective, transparent and accountable administration;

Mr. Salahuddin and Ms Nusrat Yasmeen, Directors of the Academy, went to Nepal to participate in a Regional Expert Consultation on International humanitarian law (IHL) with the Judicial Sector, organized by the National Judicial Academy of Nepal in partnership with the International Committee of Red Cross (ICRC), on September 3, 2016 in Kathmandu.

The objective of the expert consultation was to increase understanding of IHL and to improve better structure in the current training pedagogical tools and teaching methods used during domestic continued professional development sessions for judges..

Judges and judicial educators from SAARC countries including Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan, besides Iran, had taken part in the expert consultation.

Hon'ble Chief Justice Sushila Karki, as the Chief Guest of the concluding session, observed that IHL issues are highly pertinent and need to be incorporated in the training curricula for judges.

During the expert consultation, presentations were made by the experts on IHL, and also group exercises were carried out to identify role of judges and judicial educators in the training curricula and their delivery in the training programme.

Presided over by Executive Director Hon'ble Keshari Raj Pandit, NJA-Nepal, the expert



consultation also adopted a four point Kathmandu Declaration exhibiting the participants' commitment to include ILH issues in the training curricula. Twenty three participants attended the expert consultation.

A three member delegation of German International Cooperation (GIZ), Rule of Law Project Assessment

team, called on Mr. Fakhar Hayat, DG of the Academy, on August 8, 2016.

The delegation comprised Mr. Richard Miles, Consultant, CIS, Ms Baisch, Representative from GIZ Headquarters, Germany and Mr. Rashid Kazmi, Technical Advisor, GIZ Pakistan.

During the meeting, Director General FJA noted the importance of cooperation between the FJA and GIZ.

He also lauded the quality infrastructure and capacity building endeavours of the Academy.

The delegation also took round of different sections of the Academy and the visit concluded with a group photo with the Faculty members.

A two-member **Nepali delegation** headed by Hon'ble Binod Prasad Sharma, Judge of High Court/Faculty member of National Judicial Academy (NJA) of Nepal, and Mr. Man Bahadur Karki, Registrar at NJA visited the Federal Judicial Academy on May 15, 2017. There was extensive exchange of views regarding various matters of mutual interest with a special focus on the promotion of quality judicial education and collaborative trainings between the two SAARC countries.

FJA Library

The Library of the Federal Judicial Academy contains more than 15000 books/reading materials. A variety of new books worth Rupees 1 million were purchased for the Library during the financial year 2016/17.

An Oriental Section has been established in the FJA Library comprising ten shelves in which

Pakistani Literature including Urdu Drama, Poetry, Novel, and Literature on Islam have been placed.

Write-off policy for the Library was duly approved by the Chairman BoG, and in the light of this policy, stock-taking of the library material was accomplished.

The Library Collection has been re-organized as per DDC Classification scheme which is user-friendly and is being used around the world in more than 90% libraries.

The Library is also offering reference services to its users by using different search engines and online legal databases to promote the research culture. The FJA Library has also the access





to the "HEC Digital Library" and online legal database "pakistanlawsite".

Information and Communication Technology

IT training is a compulsory part of the regular curriculum of the Academy. It is intended to enable the course participants to improve their computer / IT skills by using computer systems and allied accessories independently for quick disposal of court matters. Information Technology is now recognized

as a useful tool for Judges, Law Officers and Court personnel including text creation, storage and retrieval; Access to the Law; Recording of Court Proceedings; Case Management and producing data for administrative purposes and Communication.

In this age of Information Technology (IT), the Federal Judicial Academy (FJA) has modernized its medium of instruction and has set up two computer labs that are equipped with latest Computer Systems and multimedia projector with interactive screen.

During a training course the trainee participants reside in the FJA hostel, therefore, Internet facility is provided round the clock to them in the hostel block of the Academy.

Research & Publications

One of the aims and objectives of the FJA is to provide judicial education by publishing journals, memoirs, research papers and reports (Section.4 (d) of the FJA Act, 1997). In compliance with the Rules, the Academy has its publications that include Journals, Memoirs, Research Papers, Reports, Bench Books and News bulletins. To keep the readers and scholars apprised of its activities, the Academy publishes its quarterly newsletter called "FJA Bulletin". It covers the overall academic, capacity building and other intellectualization activities on the campus and also contains articles from "Essay Competition," that is regularly held amongst the trainee judges. The

"FJA Bulletin" is disseminated to all the High Courts which they circulate amongst heads of district judiciary for onwards sharing with their judicial officers. It is also available on the website of the Academy, i.e. Www.fja.gov.pk.

A booklet authored by Hon'ble Mr. Justice Ghulam Rabbani, Judge, Supreme Court of Pakistan, called "A Treasure Trove," was published on July 2013.

Other Facilities at FJA

The FJA is an ideal setting for the pursuit of judicial training. It is located at a scenic place and housed in a beautiful building with well-equipped lecture hall, syndicate rooms, mock court room, guest room and a spacious auditorium.



The Federal Judicial Academy Act, 1997

ACT NO XXVIII OF 1997

An Act to provide for the establishment of the Federal Judicial Academy

WHEREAS it is necessary to provide for the proper training of judicial officers and Court personnel in order to improve the professional competence of judges and the quality of justice administered in the Courts;

It is hereby enacted as follows:---

1. Short title and commencement.

- (1) This Act may be called the Federal Judicial Academy Act, 1997.
- (2) It shall come into force at once.

2. Definitions.

In this Act, unless there is anything repugnant in the subject or context,---

- (a) "Academy" means the Federal Judicial Academy;
- (b) "Board" means the Board of Governors of the Academy;
- (c) "Chairman" means the Chairman of the Board;
- (d) "Director-General" means the Director-General of the Academy;
- (e) "prescribed" means prescribed by rules made under this Act; and
- (f) "staff" means members of the staff of the academy, including contract employees, part time employees and deputationists.

3. Name and location.

- (1) The Academy shall be called the Federal Judicial Academy.
- (2) The Academy shall be a body corporate having perpetual succession and a common seal with power to acquire, hold and dispose of property both movable and immovable and shall by the said name sue and be sued.
- (3) The headquarters of the academy shall be at Islamabad.

4. Aims and objects.

The aims and objects of the Academy shall be,---

- (a) orientation and training of new judges, Magistrates, law officers and Court personnel;
- (b) in service training and education of Judges, Magistrates, law officers and Court personnel;
- (c) holding of conferences, seminars, workshops, and symposia for improvement of the judicial system and quality of judicial work; and
- (d) publishing of journals, memories, research papers and reports.

5. The Board.

(1) The Board shall consist of,---(i) The Chief Justice of Pakistan. *Chairman*. (ii) The Minister for Law, Justice and Parliamentary Affairs. *Vice-Chairman*. (iii) The Attorney-General for Pakistan. *Member*. (iv)

The Chief Justice of Lahore High Court. *Member*(v) The Chief Justice of High Court of Sindh. *Member*(vi) The Chief Justice of Peshawar High Court. *Member*(vii) The Chief Justice of Balochistan High Court. *Member*(viii) The Secretary, Ministry of Law, Justice and Parliamentary Affairs. *Member*(ix) The Director-General of the Academy. *Member/Secretary*.

6. Powers and functions of the Board.

For carrying out the aims and objects of the Academy, the Board shall, inter alia,---

- (a) exercise general supervision over the affairs of the Academy;
- (b) lay down the policy and programme for training and approve courses of training;
- (c) evaluate and examine the activities of the Academy;
- (d) approve and consider the annual budget and revised budget estimates;
- (e) receive grants-in-aid from the Federal Government, Provincial Governments and aid giving agencies;
- (f) cause proper books of account to be maintained for all sums of money received and expended by the Academy and arrange for audit by the Auditor-General of Pakistan;
- (g) prescribe the terms and conditions of service of the Director-General and member of the staff;
- (h) create, abolish, suspend and upgrade posts;
- (i) prescribe duties of the members of the staff;
- (j) appoint, suspend, punish, dismiss or remove from service any member of the staff;
- (k) purchase, hire, construct or alter any building for the Academy;
- (I) hold, control and administer the movable and immovable property, assets and funds of the Academy;
- (m) regulate, determine and administer all matters concerning the Academy;
- (n) affiliate with Provincial judicial academies and other training and educational institutions; and
- (o) decide any other matter ancillary and incidental to the aims and objects of the Academy.

7. Delegation of powers.

- (1) The Board may delegate all or any of its powers and functions to she Chairman, Vice-Chairman, any member of the Board, the Director-General or any Member of the staff.
- (2) The Director-General may, in any emergency which in his opinion requires immediate action, exercise such powers as he may consider necessary in the circumstances, and shall report the action taken by him for approval of the board at its next meeting.

8. Appointment of advisors, consultants and experts.

The Board may appoint advisors, consultants and experts for assisting the Board in fulfilment of its aims and objects.

9. Meetings of the Board.

- (1) The meetings of the Board shall be called by the Chairman on such date and at such time and place as he may specify.
- (2) Subject to subsection (1) the intervening period between two meetings of the Board shall not exceed six months.

(3) The Chairman or, in his absence, the Vice-Chairman, or if the Vice-Chairman is also absent, the member elected by the members for the purpose, shall preside at a meeting of the Board.

- (4) The Quorum for the meetings of the Board shall be four members.
- (5) The Board may, from time to time, appoint such committees and working groups, from amongst its members or otherwise, as it may consider necessary.

10. Director-General.

- (1) The Director-General shall be appointed by the Chairman on such terms and conditions as may be approved by the Board.
- (2) The management of the Academy shall be carried on by the Director-General under the general directions of the Board.
- (3) The Director-General shall be the academic and administrative head of the Academy and shall be responsible for the maintenance of good order and discipline.
- (4) The Director-General shall be the Principal Accounting Officer of the Academy.

11. Appointment of officers and members of staff of the Academy.

- (1) The members of the staff of the Academy shall be appointed by direct recruitment or transfer, or deputation or on contract basis or otherwise in such manner and on such terms and conditions as may be approved by the Board.
- (2) All appointments of the members of the staff to posts in Basic Pay Scales 1 to 16 shall be made by the Director-General with the approval of the Chairman.
- (3) Appointment of the members of the staff to posts in Basic Pay Scale 17 and above shall be made by the Chairman.
- (4) Notwithstanding anything contained in any contract or agreement or in the conditions of service, all persons serving in connection with the affairs of the Academy immediately before the commencement of this Act, other than persons so serving on deputation, shall stand transferred to the Academy and become the employees of the Academy on the same terms and conditions to which they were entitled immediately before such commencement and shall, on such transfer, cease to be persons in the service of Pakistan.

12. Funds of the Academy.

- (1) There shall be a Fund of the Academy to be known as the "Academy Fund" to which all its income shall be credited and from which all its expenditures shall be met.
- (2) The following shall be the sources of income for the Academy Fund,---
- (i) grants from the Federal Government;
- (ii) grants from the Provincial Governments;
- (iii) sale and other proceeds of the Academy's publications;
- (iv) aid from national and international agencies; and
- (v) fees, charges and donations.
- (3) The Academy Funds shall vest in the Board and the moneys to the credit of the fund shall be kept in a


personal ledger account in the Government Treasury or, with the approval of the Board, in a scheduled bank.

13. Budget.

- (1) The Director-General shall, in respect of each financial year, submit for approval of the Board, by such date and in such form as may be prescribed, a statement showing the estimated receipts the current and development expenditures and the sums required as grant-in-aid from the Federal Government.
- (2) The Director-General shall not incur any expenditure from the Fund which is not provided for in the Budget approved by the Board.

14. Annual reports, etc.

- (1) Within two months of the conclusion of each financial year, the Director-General shall submit the annual report to the Board in respect of various activities carried out by the Academy during the previous year.
- (2) The Board shall submit an annual report to the Federal Government relating to the Academy Fund and the Academy's programmes.
- **15. Power to make rules.**--The Board may, with the approval of the Federal Government, make rules for carrying out the purposes of this Act.
