Mr. Justice Qazi Faez Isa, Hon'ble Judge, Supreme Court of Pakistan, has graced the ceremony as the chief guest and distributed certificates among lawyers. A total of 46 lawyers from ten Balochistan's Bar Associations attended the course.

In the one-and-a-half-hour interactive unique session, the Honourable Judge of Apex court posed several thought-provoking questions from the participants regarding the verses from the glorious Quran which was recited with its Urdu translation at the outset

of the ceremony, which reads as, "Everything in the heavens and everything in the earth belongs to Allah. Whether you divulge what is in yourselves or keep it hidden, Allah will still call you to account for it. He forgives whoever He wills and He punishes whoever He wills. Allah has power over all things."

"Since human beings are declared as the Vicegerent of Allah, their responsibility towards His creation is delicate and demanding. We have to be mindful of our responsibilities as Khalifa-tul-Arz. We should always strive to improve things, including environment, ecology, protect and preserve biodiversity and use resources judiciously. Above all, we have to be more humane and sensible in our attitudes and behavior towards others in this universe because everything belongs to Allah and we are just custodians and guards of it," he remarked.

While highlighting the role of lawyers, Mr. Fakhar Hayat, Director General Federal Judicial Academy has said that the Bench cannot fulfill its obligation of delivering justice effectively without the cooperation and support of professional Bar members.

He expressed these views at the inaugural ceremony of the first ever one week Capacity Building training organized by FJA for the members of Balochistan's Bar Associations which began here at the Academy on February 12, 2018.

Hence the need for training of lawyers, Mr. Fakhar Hayat further stated that, "Like for other stakeholders within the administration of justice system, the Academy recognized the pressing need for adequate training for

members of different Bar Associations. This training for the young lawyers from the province of Balochistan has been organized as a result of consistent efforts of the Honourable Chief Justice of Balochistan High Court."

While remembering the members of legal fraternity who had lost their lives in the Quetta carnage on August 8, 2016, Mr. Fakhar Hayat maintained that, "It was an irreparable loss for all of us, but now the best way to pay tribute to those departed souls is that you should develop strong professional skills to improve your creativity, efficiency and productivity and you should try to gain maximum learning from this capacity building training and serve the litigant public with due diligence for the sake of your people." ■

Since courts are a cornerstone of our society, in the face of emerging challenges and professional deterioration our courts need a highly qualified, competent and well-trained manpower so as to provide quality judicial services more efficiently."

He expressed these views in the certificate awarding ceremony at the conclusion of a one-week training Course on "Effective Administrative/Financial Management" for Senior Civil Judges from all over Pakistan Gilgit-Baltistan held at the Federal Judicial Academy, Islamabad, on January 27, 2018.

Special Judge stated that, "Our judicial officers should administer funds in accordance with sound, accepted financial management practices.

Judge Shakeel Ahmad further stated that, "Our courts need judges with the highest ethical standards, extensive legal knowledge,

and complex and unique skills in leadership, decision-making, and administration. Courts similarly need highly professional, ethical and competent staff. The court management team should work to enhance the performance of the judicial system as a whole by continuously improving the personal and professional competence of all persons performing judicial branch functions."

"All judicial officers and court staff should have clear expectations of effective performance along with transparent systems to evaluate that performance. We need to develop education and training programs that provide judicial officers and court personnel the knowledge and skills required to perform their responsibilities fairly, correctly and efficiently while adhering to the highest standards of personal and official conduct, he observed.

delivery to the people make and magnify the institutions. We must have zero tolerance for corruption to dilute the adverse people perception and give pollution-free decision, without Fear or Favour.

Earlier, Mr. Fakhar Hayat, Director General of the Academy presenting his welcome address, brief introduction of the learned chief guest and an overview of the training course.

"The subjects and topics which you have been taught here, those are not taught in the law colleges, but these become an inevitable need of court system. You have been introduced and sensitized about these subjects and now you have to widen your knowledge and improve your performance by reading and seeking guidance from the relevant books," DG concluded. ■

Lack of capacity delays expeditious dispensation of justice Niaz Muhammad Khan, Chairman, Khyber Pakhtunkhwa Service Tribunal
